Impact Seven, Inc., a Wisconsin based community development corporation, first approached the City in 2021 inquiring about the availability of the "Frost Site" at 6523 14th Avenue for an affordable housing development.

Impact Seven held neighborhood meetings and worked with Staff and the Plan Commission on design of the proposed development. The City rezoned the site to B-4 Mixed Use, and the Plan Commission reviewed a conceptual plan, provided input and plans were revised. Impact Seven was given an option on the site to pursue low income housing tax credits. Impact Seven did not receive an allocation of tax credits in 2022 or 2023.

Impact Seven approached the City again this year and is working with a new architect on changes to the project's design, partially necessitated by new requirements from the Wisconsin Housing and Economic Development Authority regarding handicap accessibility to all units within a development. The revised design will be reviewed by the Plan Commission at its January 18, 2024 meeting.

The attached option would provide Impact Seven the opportunity to apply for WHEDA Tax Credits. The option would run until 90 days after WHEDA has made a decision on granting 2024 tax credits. The option provides for City approvals including, "City Approval of the Aesthetics of the Design".

We recommend approval of this option.

#### **OPTION TO PURCHASE**

#### **Frost Flats**

6523 14<sup>th</sup> Avenue Tax Key 05-123-06-282-001

THIS OPTION TO PURCHASE ("Agreement") is entered into this 10th day of January, 2024 (the "Effective Date") by and between the City of Kenosha ("City") and Impact Seven, Inc. ("Impact").

### RECITALS

- A. City owns that certain real property located at 6523 14th Avenue, in the City of Kenosha, Wisconsin ("Property") more particularly described in Exhibit A attached hereto.
- B. Impact desires to acquire the Property and develop an affordable housing project with approximately seventy-two (72) units ("Project").
- C. City has demonstrated that it is amenable to the Project by granting Impact's previous request to rezone the Property.
- D. City of Kenosha Plan Commission is amenable to the Project and to that end has reviewed conceptual plans for the Project, subject to modifications it may request.

### **AGREEMENT**

For and in consideration of the sum of One Dollar (\$1.00) tendered herewith, the City does hereby grant unto Impact an option to purchase the Property on the following terms and conditions:

- 1. Purpose. Subject to the conditions herein, this Option is granted for the purpose of granting the exclusive right to Impact to purchase the Property in order to construct the Project. From and after the Effective Date, and until this Agreement is terminated, City shall not enter into any new contracts or agreements relating to the Property, including without limitation, mortgages or other instruments that encumber the Property, leases, options, rights of first refusal, or any other agreement that impairs Impact's exclusive right to purchase the Property.
- 2. <u>Terms.</u> The Parties agree that the purchase price for the Property shall be One Dollar and no/100 (\$1.00). All terms and obligations for the sale of the Property are subject to negotiations satisfactory to the Parties including, but not limited to, (1) City approval of the aesthetics of the design, (2) environmental approvals, (3) affordable housing requirements/limitations, (4) indemnification obligations, (5) the parties' respective duties and obligations and (6) any contingencies to be set forth in an Offer to Purchase to be executed by the parties at a future date.
- 3. Option Period. This Option shall commence on the Effective Date and unless terminated by mutual agreement shall continue in effect for a period of ninety (90) days after the Wisconsin Housing and Economic Development Authority has determined whether to grant the Project Low Income Housing Tax Credits for the 2024 calendar year. Should Impact fail to exercise its option before the expiration of the Option period, this option shall be null and void and neither party shall have any further obligation hereunder.

- 4. <u>City's Warranties and Representations</u>. City hereby makes the following warranties and representations with respect to the Property:
  - a. City has the full power and authority to enter into this Option.
  - b. To the best of City's current and actual knowledge, City has not received, and City has no knowledge of any predecessor receiving, notice of any violation of any law, municipal ordinance or other governmental requirement affecting the Property. City has no knowledge that any governmental authority is contemplating issuing such notice or that any such violation exists.
  - c. To the best of City's current and actual knowledge, City is not a party to any agreement, contract or commitment to sell, convey, lease, assign, transfer, provide option rights, provide rights of first refusal, or otherwise give any third party any rights to use or occupy all or any part of the Property.
  - d. To the best of City's current and actual knowledge, there are no condemnation or eminent domain proceedings, nor any negotiations in lieu of condemnation, pending against the Property, and City is not aware of any condemnation or eminent domain proceedings being contemplated or threatened against the Property.
- 5. <u>Notices</u>. All notices and demands by either party to the other shall be given in writing and personally delivered or sent by overnight commercial courier and addressed:
