- **22nd Avenue from 81st Street to 85th Street**
One lane of southbound traffic on 22nd Avenue maintained between 81st Street and 85th Street. Northbound traffic is detoured 85th Street to Sheridan Road to 80th Street.

- **54th Avenue from 58th Street to 54th Court**
56th Avenue from 55th Street to 52nd Street
Road closed to through traffic, local access maintained.

- **60th Street from 50th Avenue to Pershing Boulevard**
One lane of eastbound traffic on 60th Street maintained between 50th Avenue and Pershing Boulevard. Westbound traffic is detoured from 39th Avenue to 52nd Street (Highway 158) to Green Bay Road (Highway 31).

- **70th Street from 5th Avenue to 7th Avenue**
Road closed to through traffic, local access maintained.

- **Pershing Blvd from 67th Street to 60th Street**
One lane of traffic in each direction will be maintained.

- **Town & Country Storm Sewer Improvement**
40th Avenue from 75th Street (STH 50) to Grant Road: Closed to through traffic, local access maintained.
40th Avenue from 76th Street to 75th Street (STH 50): Closed to through traffic, local access maintained.
75th Street (STH 50) at 40th Avenue: Traffic lanes reduced.
