2.5% convenience fee for credit/debit card (MC, Visa, Discover)

Please write your phone number on the check &

include a self addressed, stamped envelope for a receipt.

### CITY HALL (625-52ND STREET) DROPBOXES

White box at the entrance to the west parking lot on 8<sup>th</sup> Avenue -  
or - white box in the west parking lot, near the door to City Hall.

Put payment by check (payable to City of Kenosha) in an  
envelope and mark the outside "City Clerk".

for your real estate tax bill. If the check is made out to you, be  
sure to endorse the check, by signing your name on the back  
before making payment. If the payment is more than the  
amount due, a refund will be mailed in 3-4 weeks.

January 1, 2020 qualify for one lottery  
credit.

Review your tax bill to determine if the  
credit has been applied. Contact us at  
262-653-4020 or [cityclerk@kenosha.org](mailto:cityclerk@kenosha.org)  
by January 31, 2021 if:

- you are unsure if there is a credit  
applied to your bill
- the property qualifies and there is no  
credit applied to your bill
- there is a credit applied to the bill and  
the property does not qualify
