**Requirements:**

1. Permit is valid for thirty (30) days. Applicant is responsible to re-apply for permit if thirty (30) days is exceeded.
2. Permits are limited to one (1) renewal period of thirty (30) days.
3. The name, address, and phone number of the dumpster/container owner must be posted on the dumpster/container.
4. The dumpster/container must have reflectorized tape or other reflector devices on it.
5. Dumpster/container cannot be placed in a traffic lane.
6. The City of Kenosha has the right to order the removal of the dumpster/container if it constitutes a safety hazard.
7. Dumpster/container must not interfere with any public works construction or maintenance done by the City.
8. Dumpster/container must not be placed within twenty-five (25) feet of any intersection.
9. Dumpster/container must not be placed in the vision clearance triangle.

**Note: Dumpsters/containers may not be in place until all required permits have been obtained.**

Applicant agrees to abide by City Ordinance 16.17.A.3 relating to the leasing and use of dumpsters and containers.

*I agree to comply with all applicable codes, statutes, and ordinances, and with the conditions of this permit; understand that the issuance of the permit creates no legal liability, express or implied, on the state or municipality; and, certify that all of the permit information herein is accurate. I expressly grant the building inspector, or the inspector's authorized agent, permission to enter the premises for which this permit is sought at all reasonable hours and for any property purpose to inspect the work which is being done.*

*I certify that in regard to the property that is the subject of this permit I either (1) have permission from the owner to apply for this permit on the owner's behalf, or (2) I am the owner.*
