After the request is received, the City Forester will review for placement and for tree selections. Once the placement is agreed upon, the tree can then be purchased, by the donor, from Swartz Nursery at 1743 30<sup>th</sup> Ave, Kenosha, WI; 262.552.8210.

<u>Tree Marker:</u> No memorial markers may be placed at the site, on or near the tree without permission from the Board of Park Commissioners. Once approved by the Board of Park Commissioners, the donor can order a memorial tree marker through <u>Bosman Monuments</u> at 6511 52<sup>nd</sup> St, Kenosha, WI 53144; 262.657.3231.

The nursery and marker manufacturer will contact the Park Department when the tree/marker is ready for pick-up, staff will then plant the tree/place the marker, and notify the contact person listed above.
